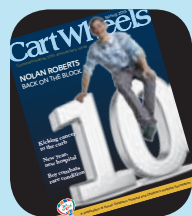
JANUARY

MAY

- Nine families are inducted into the Wade Mountz Heritage Society after making gift commitments totaling \$1.5 million to benefit adult and pediatric health and wellness initiatives across the Norton Healthcare system. The society recognizes individuals who have made irrevocable planned gifts of \$100,000 or more to the foundations.



- Chili's Clip for Kids raises approximately \$90,000 in its second year for the Addison Jo Blair Cancer Care Center at Norton Children's Hospital.



More than 500 people participate in the event, which encourages participants to raise funds in return for shaving, trimming or clipping their hair in solidarity with kids fighting cancer at Norton Children's Hospital.

JUNE

- The sixth annual Bourbon & Bowties: A Taste of Corbett's raises more than \$270,000 for Norton Children's Hospital. Chefs descend on Corbett's: an American Place to serve up delectable hors d'oeuvres for a packed crowd.
- Norton Children's Prevention & Wellness helps pass House Bill 315, which brings Kentucky law up to national standards and protects more children. The law now requires booster seats to be used by children who are younger than 9 years old and between 40 and 57 inches in height.

- The annual Wings for Kids Radio Controlled Airshow raises nearly \$30,000, with 100 percent of proceeds benefiting the Norton Children's Hospital "Just for Kids" Transport Team.

JULY

- Norton Children's Hospital names Mark J. McDonald, M.D., as new medical director. He succeeds Stephen Wright, M.D., who retired after serving as medical director for 19 years.

AUGUST

- Norton Children's Hospital uses extracorporeal membrane oxygenation (ECMO) on the 1,000th patient and becomes a designated ECMO center of excellence.



- The inaugural Norton Children's Hospital Splash 'n' Dash 5k Walk/Run takes place at Beckley Creek Park, raising more than \$20,000 for pediatric services and programs.

More than 1,000 participants dash their way through numerous splash zones in this family-friendly event.

SEPTEMBER



- Norton Women's & Children's Hospital unveils a new pediatric emergency department, marking completion of the first of a three-phase project to renovate services at the St. Matthews facility.

- Norton Children's Medical Associates – Broadway opens.

- Hyundai Hope on Wheels and Greater Louisville-area Hyundai dealers award a \$250,000 research grant to Norton Children's Hospital to support pediatric cancer research in honor of National Childhood Cancer Awareness Month.

- Norton Children's Medical Associates – Middletown opens.

- Specialists at Norton Children's Hospital perform surgery to separate 7-week-old conjoined twin girls.
