

OFFICIAL RULES

Entry form(s) must include name, address and telephone number of entrant to be considered a valid entry. Only original entry forms will be accepted, no duplication is permitted. - 4. DRAWING.** A random drawing will be held under the supervision of BB&T and the Children's Hospital Foundation on or about June 30, 2017. The Children's Hospital Foundation will make reasonable attempts to contact the winner either in person by telephone within five (5) business days of contest drawing. In the event the Children's Hospital Foundation is unable to contact the winner, the Children's Hospital Foundation reserves the right to conduct a second random drawing and award the prize to another qualified entrant or, (b) not award the prize. Personal contact is required, notification of winning entry will not be left on telephone answering machines.
